## **Terms and Conditions of Registration**

### **Conditions of Registration**

In consideration of the Capital Badminton Club accepting the member's application in the club, the member agrees to adhere to all Capital Badminton Club rules, regulations, policies, procedures and player code of conduct in respect to the program and to abide by all terms and considerations of registration.

### **Returned Cheque Fee**

A \$25.00 service fee will be levied on all cheques returned as Non Sufficient Funds (NSF); Stop Payment; or Funds not Cleared.

### **Refunds**

Refunds will only be made for medical reasons upon presentation of a medical certificate. The amount of the refund will be based on the membership fee prorated by the number of full months remaining in the season at the time of the request made by the member.

### **Severe Allergies**

It is the responsibility of the member or parent/guardian of the member to identify themselves or their child(ren) if they have a severe allergy and/or require an Eppipen ®. Members or parent/guardians of members will be required to sign a release waiver.

### **Physical Activity Readiness Questionnaire (PAR-Q)**

Members may be required to complete a PAR-Q, and in some circumstances, consult with their physician prior to their participation.

### **Code of Conduct**

In an effort to provide members with a safe and enjoyable environment, the Capital Badminton Club will adopt a zero tolerance approach towards physical or psychological abuse, as well as intentional damage to Capital Badminton Club property and the property of others. The Capital Badminton Club reserves the right to take necessary measures including, but not limited to, suspension or termination of membership and/or contacting the police when any participation contravenes Capital Badminton Club policies, procedures and/or by-laws.

**Indemnification**

I, as the member or on behalf of the member, agree that by registering in the club, the member is knowingly and freely assuming certain injury and legal related risks. A member's participation in the club will be deemed to indicate acceptance of such risks. The member, his/her heirs, executors and administrators agree to indemnify and hold harmless the Capital Badminton Club liable from all claims, demands, actions or causes or action, loss, costs or damages that the Capital Badminton Club may suffer, incur or be liable for in relation to any injury the Member may suffer or cause to others in connection with his/her negligence or action while participating in the club. Furthermore, the member, or parent/guardian of the member is unaware of any health-related problems that the member may have that could cause injury to himself/herself while participating in the club.

I also acknowledge having carefully read, understood and agreed to the above Terms and Conditions of Registration. I understand that the Capital Badminton Club reserves the right to require the member or parent/guardian of the member to sign a printed copy of these Terms and Conditions of Registration along with a waiver as a prior condition to admittance into the club. Furthermore, I understand that the member or parent/guardian of the member may be required to complete and sign additional documentation related to a specific program.
