

Capital Badminton Club

Club Regulations

1. Members and any persons attending the Capital Badminton Club (CBC) shall ensure that they comply with all rules and regulations posted in the facility and/or on the property, and with all directions given by Turnbull School (TS) representatives.
2. CBC members and any persons attending the club shall only have access to the: gymnasium, male & female change rooms & washrooms, and art room.
3. CBC members and any persons attending the club with a motor vehicle shall not park same anywhere other than in one of the two parking lots that form part of the property and shall comply with any restrictions on parking as may be posted or otherwise designated in those lots.
4. CBC members and any persons attending the club must change into appropriate athletic footwear and must not enter the gymnasium in shoes that have been worn outside. The use of shoes marking the surfaces is strictly prohibited. All spectators must remove their shoes before entering the gymnasium.
5. Smoking, alcoholic beverages, gambling or illicit substances are strictly prohibited within the facility or otherwise within or on the property known municipally as 1132 Fisher Avenue.
6. Any Member or guest attending the club will be asked to leave if he or she is intoxicated and/or causing a disturbance.
7. Aisles, fire exits, lobbies, passageways, stairways or doorways are not to be blocked by members or by anyone attending an event or activity.
8. Members agree not to use, store, or permit to be used or stored in or on any part of the premises any flammable, combustible or explosive fluid, material, chemical or any substance prohibited by any law or by TLC policy.
9. Members shall not permit garbage or debris to accumulate at the facility or otherwise within or about the premises. TLC will provide a garbage bin in, or near, the gymnasium.
10. Members shall be solely responsible for their own safety and the safety of their guests attending the club. Protective eyewear is strongly recommended for all players.
11. Members shall comply with all laws, orders and regulations of any level of government and with any TLC policy or procedure.

12. Members shall not do or permit to be done any act which shall or might subject TLC and/or the Capital Badminton Club to any liability or responsibility for injury to any person or persons or to property by reason of such activity.
13. The Member shall indemnify TLC and the Capital Badminton Club against any loss, damage, injury or death suffered from the use of the facility or the premises and for any loss or damage to property of TLC or the CBC caused by the negligence of the member.
14. The member shall not damage the facility or any other property or equipment belonging to TLC or the CBC. The member assumes all responsibility of any damages caused by the member and their guest(s) to the facility, property or equipment of TLC or the Capital Badminton Club. The member agrees to be responsible for the cost of repair or replacement of any TLC or CBC property lost, stolen, damaged, destroyed or defaced by the member or their guest(s). Any such damage may be repaired or replaced by TLC and/or CBC and all costs so incurred by TLC and/or the CBC shall be payable by the member on demand.
15. TLC and the CBC shall not be responsible for any loss or damage, theft or destruction of the member's property by any cause of whatever nature.
16. At the end of each evening, the member agrees to leave the facility in a clean state.
